

Nissan North America's Vehicle Purchase Program (VPP)

As a part of Nissan's athletic partnership with Florida State University, all full-time university employees are eligible for preferred pricing on new Nissan and Infiniti vehicles. Florida State University employees will receive preferred pricing and can also continue to take advantage of all other consumer facing market incentives.

VPP Plan Details

- Florida State University Employees who wish to purchase a vehicle for themselves or their spouse/domestic partner must use their Florida State University VPP Company code: VPP018625 and create a VPP Claim ID on the VPP website (www.insidenissan.com), or by calling 1-800-299-4753.
- Eligible employees, which are considered all direct, full-time employees of Florida State
 University and their spouse/domestic partner in the continental United States, Hawaii,
 and Alaska, can create <u>2</u> claims per calendar year. Vehicles purchased cannot be titled
 in a business's name.
- Retirees, immediate family, and extended family & friends of Florida State University are not eligible.
- A copy of the Florida State University employee's recent paycheck stub (monetary amounts and confidential information may be redacted) noting employee name and university name is required to verify proof of employment with Florida State University.
 A university issued employee badge, or a dated letter from the university's Human Resources office (along with contact information and verification of current employment) will also be accepted.

- 1. Visit InsideNissan.com
- 2. Click "Business Associate" and enter your name and university VPP Code.
- 3. Search your nearest dealer's inventory and create your VPP Claim ID.
- **4.** Visit your nearest dealer with your printed Claim ID and proof of eligibility.
- 5. Choose your vehicle, and drive off for less!
